Prerequisite for Earning Global Community Royalty (GCR) through Upgrades: 1. To qualify for Global Community Royalty (GCR) based on your Top-up/Upgrade, it is essential to introduce new members or upgrade existing members in your personal community using the same amount you have top-up or upgraded with. This criterion must be fulfilled to unlock the potential to earn GCR and maximize your earnings within the Wellness Bharat Global Community. Please note that joining higher communities such as GC180 requires a step-by-step process starting from GC015, then progressing to GC045, GC090, and finally joining GC180.

2. Please note that you are not able to top-up your own IDN with the amount associated with your current community. For instance, if you are currently in GC090, you cannot top-up with GC090; instead, you can only upgrade to Gc180.

#### Terms and Conditions for Community Royalty Withdrawal:

To qualify for withdrawal of Community 1 (IWE), a minimum of 100 PBV is required. For Community 2 (Global Gold), a total of 225 PBV is necessary, including the PBV from Community

 Additionally, for Community 3 (Global Platinum) and Community 4 (Global Diamond), a combined minimum of 450 PBV is mandatory.

Please note that the PBV criteria shall be applicable from the 30th day of signing up with Wellness Bharat Community Plan.

This means that distributors must meet the respective PBV requirements starting from the 30th day after their initial registration to become eligible for the Auto Generated Global Income (GCR). Failure to meet the specified PBV criteria will render the distributor's DN (Downline Network) ineligible

for the Auto Generated Global Income for that particular month. It is crucial to ensure compliance with these PBV requirements to maintain eligibility for the Auto Generated Global Income.
